In line with the 'Civil Service Renewal 2024 -Action Plan', which advocates for training for across the wider public service, PAI is now taking applications for the Training Card Incentive Scheme 2023.

Public Sector organisations who avail of the incentive in December will be granted an additional 10% in training credits, to be used on any training during 2023, including Accredited Certified Courses, Online Seminars, Bespoke In-House and eLearning Programmes. This credit must be used by the end of 2023.

Your training credits can be spent on a range of training for all personnel in your organisation, from high level leadership programmes to programmes for your legal team or HR/people managers, compliance or regulatory personnel, admin, and front-line staff.

Furthermore, you may have bespoke inhouse or eLearning programmes developed specifically for your organisation. In-house courses are courses delivered onsite or online to a closed group of colleagues from your organisation. This means that although a course may not be scheduled to run publicly, you can have it run in-house (online or in-person) for your staff. Bespoke eLearning programmes may also be created and be deployed on your internal eLearning platform or accessed via our eLearning platform.

All of our existing training programmes can be tailored for your organisation, or if you would like us to develop bespoke training programmes along with Industry experts, we can develop and deliver these programmes for you.

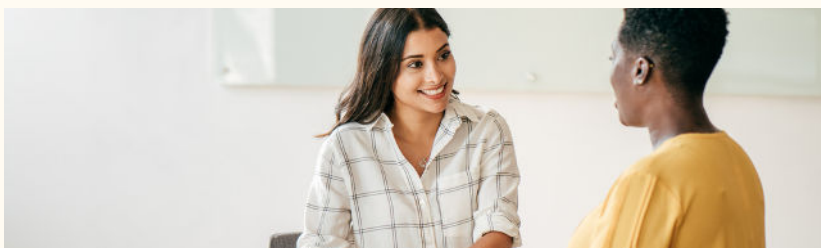
